

In exercise of the powers conferred by Article 233(1) of the Constitution of India read with Rule 6(1) of the Tripura Judicial Service Rules, 2003, and on recommendation of Hon'ble the High Court of Tripura *vide* its letter No. F.11(2)(a)-HC/2019/5240-43 dated 18th March, 2019, Hon'ble the Governor of Tripura, is pleased to appoint **Shri Gobinda Das**, Chief Judicial Magistrate –cum- Civil Judge (Sr. Div.), North Tripura Judicial District, Dharmanagar (a Grade – II Judicial Officer of Tripura Judicial Service), on promotion to **Grade – I** of the said Service on regular basis, in the scale of pay of Rs.51,550-1230-58,930-1380-63,070/- (Unrevised) plus other allowances as admissible under the rules from the date of his joining in the Grade.

2. The posting order of Shri Gobinda Das shall be issued separately by the High Court and Shri Das shall exercise his powers as prescribed by Law within the jurisdiction of the Judicial District in which he may be posted.
3. The Order will take effect from the date of his taking over charge in the grade.
4. This is issued after obtaining clearance from the Election Commission of India as communicated *vide* Letter No. F.19(51)-CEO/CONDT/2019/10752-54 dated 5th April, 2019 of the office of the Chief Electoral Officer, Tripura, Agartala.
