**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura in consultation with the Tripura Public Service Commission is hereby pleased to make the following rules regulating the method of recruitment to the post of Assistant Director in the Directorate of Sainik Welfare under the General Administration (Political) Department namely:-

**1. Short title commencement:-**

- a) These rules may be called 'Recruitment Rules, 2019 for the post of Assistant Director in the Directorate of Sainik Welfare under the General Administration (Political) Department, Government of Tripura.
- b) This shall come in force from the date of publication in the Official Gazette.

**2.** The name of the post(s) shall be as specified in **Column-1** of the Schedule annexed hereto.

**3. Number, Classification and scale of pay:-**

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in **Column 2 to 4** of the Schedule annexed hereto.

**4. Method of recruitment, age limit, qualification etc.**

The method of recruitment to the said post, age limit, qualifications and other matters relating to the said post shall be as specified in **Column 5 to 13** of the said Schedule.

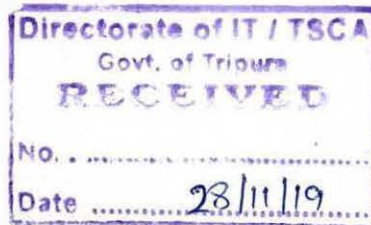
**5. Disqualification:- No person,**

- a) Who has entered into or contracted a marriage with a person having spouse living;

OR

- b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:-

Provided that the State Government may, if satisfied that such marriage is permissible under the Personal Law applicable to such a person and the other party to the marriage that there are other grounds for so doing, exempt any person from the operation of this rules.


**6. Power to relax:-**

Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in the writing and in consultation with the Tripura Public Service Commission, may relax any of the provisions of these rules with respect to any class or category or persons.

**7. Repeal and Saving:-**

- (i) The Rules namely Assistant Director under the Rajya Sainik Board, Government of Tripura issued vide Notification No.F.18(26)-P/75 dated 26<sup>th</sup> July, 1986 are hereby repealed, Provided further that any appointment made or order issued, action taken or anything whatsoever done under the rules so repealed shall be deemed to have been made, issued, taken or done under the corresponding provisions of these rules.
- (ii) Nothing in this Rule shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

4.	Scale of Pay	Pay Matrix –Level 13, Rs. 47,600 – 1,51,100/- subject to revision by the Government from time to time
5.	Whether Selection post or Non-Selection post	Selection
6.	Age limit for direct recruitment	52 years
7.	Educational and other qualification required for direct recruitment	Matriculate of a recognized board and at least an Ex-service officer of the rank of Capt./Lt./2 <sup>nd</sup> Lt. / Sub Major/Sub (Hony Capt) and its equivalent rank in the Navy and Air Force.
8.	Whether age and Educational qualification prescribed for direct recruits will apply in the case of promotion	Educational Qualification:- Yes Age: - No.
9.	Period of probation, if any	2(two) years
10.	Method of recruitment. Whether by direct recruitment or by promotion or by deputation / transfer and percentage of the vacancies to be filled by various methods.	By promotion failing which by direct recruitment

15	Repeal :	The existing Recruitment Rules for the post of Assistant Director, Directorate of Sainik Welfare, Tripura notified vide Political Department Notification No.F.18(26)-P/76 dated 26 <sup>th</sup> July, 1986 stand repealed.
