NOTIFICATION

The State Government of Tripura has decided on 03.01.2023 to unbundle the transmission activities into a wholly owned subsidiary of Tripura State Electricity Corporation Limited (TSECL).

Therefore, in pursuance of letter No.F.1(1)/Power/TPTCL/2023/Vol-I/518, dated 17th January, 2023 of State Government of Tripura, the TSECL hereby notifies "Tripura State Electricity Reforms Transfer Scheme (Provisional) - 2023" for providing and giving effect to the transfer of properties, interests, rights, assets, liabilities, obligations, proceedings and personnel relating to the transmission activities of Tripura State Electricity Corporation Limited to 'Tripura Power Transmission Limited (TPTL)' and for matters incidental and ancillary thereto.

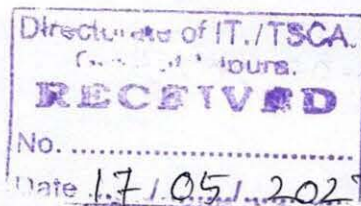
