Notification

In suppression of the earlier notification issued vide No. 4(1)-DOT/Mark/2024/8404-8414 at 17/01/2026 of the Tourism Department, in compliance to the recommendations of the compliance Reduction and Deregulation Docket : Phase-II (Tripura) Deregulation Cell, Cabinet Secretariat, Govt. of India and under Ease of Doing Business (EoDB) and also for development of Tourism Industry in the State of Tripura, Tourism Department is pleased to notify the amended guide lines for Homestays in Tripura 2024 as under :-

- i) In the eligibility criteria, at para no. 3(b) i.e. "the owner or his legal representative or promoter of the Homestay unit should be physically residing in the same Homestay is replaced with "the owner or his legal representative or promoter of the Homestay unit need not compulsorily reside in the same Homestay Unit."
- ii) In the eligibility criteria at para no 3 (c) "a minimum of 1 (one) room and maximum of 5 (five) rooms with modern toilet facilities exclusively for tourist accommodation" is replaced with.... " a minimum of 1 (one) room and maximum of 10 (ten) rooms with modern toilet facilities exclusively for tourist accommodation".
- iii) The eligibility criteria at para no 3 (e) is omitted.
- iv) In para No (6) & (7) the following sentence shall be inserted "application for Registration, Self Renewal and Appeal shall be submitted online in the Tourism portal tripuratourism.gov.in/onlineservice

This notification will take immediate effect.
