
NOTIFICATION

2. The complaint Committee shall-

- 1) Monitor the complaint(s) relating to sexual harassment of working women of the Department and to look into the matters of appropriate Redressal mechanism in that regard.
- 2) Receive and inquire into the complaint(s) of sexual harassment of working women within the Department, made directly to the Committee, for time bound disposal.
- 3) Render advice to the appropriate authority on its own motion or otherwise, on the complaint(s), including the following points:-
 - a) Whether any conduct amounts to specific offence under IPC or any other law for the time being in force;
 - b) Shall submit report to the LR & Secretary, Law, Government of Tripura after making inquiry into the complaints received ;
 - c) Action to be taken on specific complaint(s);
 - d) Make an annual report to the LR & Secretary, Law, Government of Tripura.
