
**NOTIFICATION**

In pursuance of Rule-7(2)(ii) of the Tripura Secretariat Services Rules, 1989 read with amendment of the said Rules, 1990, the Governor, in consultation with the Tripura Public Service Commission, is pleased to appoint the following Grade-II (Under Secretary) Officers of the Tripura Secretariat Service to the post of Grade-I(b) (Deputy Secretary) of the service, on ad-hoc basis as a one time measure in the pay at the Level-16 of the Tripura State Pay Matrix, 2018 with prospective date subject to final outcome of S.L.P (C) No.19765 – 19767 of 2015 pending in the Hon'ble Supreme Court of India :-

3. The above Officers shall continue to hold the post presently held by them until further orders.
4. The appointment on ad-hoc promotion as one time measure shall be on the following conditions :-
  - (i) Appointment on Promotions are allowed purely on ad-hoc basis subject to final outcome of the SLP pending before the Hon'ble Supreme Court of India.
  - (ii) No inter-se seniority shall be determined / published in respect of these ad-hoc promotions.
  - (iii) This ad-hoc appointment on promotion shall not be treated as regular appointment on promotion.
