NOTIFICATION

No.154/TP/2021-P.Admn. – In exercise of the powers conferred by sub-section (1) of Section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Government of Tripura hereby designates Sh. Gitte Kirankumar Dinkarrao, IAS (TR:2005) as the Chief Electoral Officer for the State of Tripura with effect from the date he takes over charge and until further orders in place of Smt. Saumya Gupta, IAS.

2. Sh. Gitte Kirankumar Dinkarrao shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Tripura, which he may be holding before such assumption of office.

3. Sh. Gitte Kirankumar Dinkarrao while functioning as the Chief Electoral Officer, Tripura shall not hold any additional charge whatsoever under the Government of Tripura except that he should be designated Secretary to the Government in charge of Election Department in the State Secretariat.
