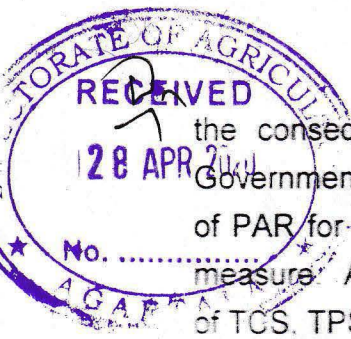

NOTIFICATION



In view of situation arising out of spread of pandemic COVID-19 and the consequence of nation-wide lockdown, it has been decided by the State Government to extend the cut-off dates prescribed for activities relating to recording of PAR for the year 2019-20 in respect of TCS, TPS & TFS officers as a one-time measure. Accordingly, the revised timeline of PAR for the year 2019-20 in respect of TCS, TPS & TFS officers in Sparrow shall be as under :-

2. Simultaneously, extension of time for the Reporting/Reviewing/ Accepting Authorities who has retired/will be retiring during the period from 29-02-2020 to 30-06-2020, shall also be allowed to record PAR in respect of TCS, TPS & TFS officers for the year 2019-20 **within 2 (two) months after 30th June, 2020.**


