**NOTIFICATION**


**WHEREAS** by a Notification of the Government of Tripura in the Law Department vide No.F.2 (6)-LAW/COM/2020/4308-19 dated 17<sup>th</sup> June, 2020, the State Government had appointed a Commission of Inquiry consisting of a single member namely Shri Goutam Debnath, retired Grade-I officer of the Tripura Judicial Service (former L.R. & Principal Secretary, Law), for conducting an inquiry into the matters related to irregularities and illegalities committed in appointment of 10,323 teachers during the year 2010 and 2013-14 in the State of Tripura and also find out the persons, if any, responsible for such appointment;

**AND WHEREAS** it was specified in the aforesaid Notification that the Commission would complete its inquiry and submit its report alongwith recommendations, if any, to the State Government on or before the 17<sup>th</sup> day of December, 2020;

**AND WHEREAS** the Commission vide letter No.F.1(Inq.Comm-1)/2020 dated 03.12.2020 communicated to this Department that it was not possible for the Commission to complete the inquiry within the stipulated time and thus the Commission had desired for extension of its term up to the month of January, 2021 to complete the inquiry;

**AND WHEREAS** the State Government having regard to the circumstances was satisfied that the term of the Commission is required to be extended for submission of its complete report to the State Government;

**AND WHEREAS** on request of the Commission, the State Government was pleased to extend the term of the Commission till 31<sup>st</sup> January, 2021;

 **AND WHEREAS** the Commission vide its letter No.F.1(Inq.Comm.2)/2020/23 dated 27.01.2021 had again requested the State Government to extend the term of the Commission upto 31<sup>st</sup> March, 2021 to complete the inquiry;




AND WHEREAS on request of the Commission, the State Government was pleased to extend the term of the Commission till 31<sup>st</sup> March, 2021;

AND WHEREAS the Commission vide its letter No.F.1(Inq.Comn.1)/2020/10 dated 18.03.2021 had further requested the State Government to extend the term of the Commission upto 31<sup>st</sup> July, 2021 to complete the inquiry;

NOW, THEREFORE, the State Government hereby extends the term of the Commission upto 30<sup>th</sup> June, 2021 and the Commission shall complete its inquiry within this period and submit report to the State Government with regard to the terms of reference as specified in the Notification No.F.2 (6)-LAW/COM/2020/4308-19 dated 17<sup>th</sup> June, 2020 and the Notification dated 17<sup>th</sup> June, 2020 shall be deemed to be amended to that extent.

This Notification shall be deemed to have come into effect on and from 01.04. 2021.


