**NOTIFICATION**

In pursuance of rule 31 of the Tripura Forest Service Rules, 1988, the Governor, in consultation with the Tripura Public Service Commission, is pleased to appoint Shri Subrata Das, TFS Grade-II to the post of Tripura Forest Service Grade-I (Selection Grade) on promotion (against SC quota as recommended), on ad-hoc basis as a one-time measure in the pay scale at the Level-17 of the Tripura State Pay Matrix 2018 allowing retrospective effect from 3<sup>rd</sup> August, 2021 i.e. from the date on which his junior Shri Jash Paul Debbarma (ST), TFS Grade-II was promoted to the Tripura Forest Service Grade-I (Selection Grade) subject to final outcome of SLP(C) No.19765-19767 of 2015 pending in the Hon'ble Supreme Court of India.

2. Pay & allowances of Shri Subrata Das, TFS will be fixed notionally as per rules. Shri Das shall continue to hold the post presently held by him until further orders.

3. The appointment on ad-hoc promotion as one time measure shall be on the following conditions:-

- (i) Appointment on promotion is allowed purely on ad-hoc basis subject to final outcome of the SLP pending before the Hon'ble Supreme Court of India.
- (ii) No inter-se seniority is determined/ published in respect of this ad-hoc promotion.
- (iii) This ad-hoc appointment on promotion shall not be treated as regular appointment on promotion.
