ORDER

Subject: - Proposal for diversion of 0.445 ha of forest land for establishment of Border Out Post at Banderkhub under District Forest Officer, South, Belonia

In pursuance to the Final approval issued by the Ministry of Environment and Forests, Regional Officer, Shillong vide letter F.No.RO-NE-TR/GEN/2005/3189-91 dated 13.02.2009 and also to comply with the order of the Hon'ble National Green Tribunal vide letter dated 24.07.2013, I am directed to state that after due consideration the State Govt. approves handing over of 0.445 ha of forest land for establishment of Border Out Post at Banderkhub under District Forest Officer, South, Belonia to the User Agency (I.G BSF) by the District Forest Officer, South with the following conditions:-

i. The legal status of the land shall remain unchanged.

- ii. All the above funds received from the User Agency under the project shall be transferred to the CAMPA Fund (CAF) in Account No.CA1596 of either Corporation Bank, Block-II, CGO Comple, Phase-I, Lodhi Road, New Delho-110 003 or Union Bank of India, Sunder Nagar Branch, New dElhi (A/CNo.344901010070128).
- iii. Additional amount of the NPV of the diverted forest land, if any, becoming due after revision of rates by Hon'ble Supreme Court of India during the validity period / tenure of forest division, shall be charged by the State Govt. from User Agency. The User Agency shall furnish an undertaking to this effect.
- iv. The forest land to be diverted shall be demarcated on ground by the User Agency with 4'feet high RCC pillars with forward & backward bearing, number of pillar and distance from one to other pillars written over them.
- v. Tree felling shall be done only when absolutely unavoidable and such removal, if any, shall be done under the supervision of the Forest Department.
- vi. Land so diverted shall reert back to the Forest Department in case it is not needed for the above use.
- vii. The forest land shall not be used for any purpose other than that specified in the proposal.

viii. Any other conditions as may be found appropriate in future for he betterment of environment & wildlife, may be imposed by CCF(C), North Eastern Regional Office.

Plantation of dwarf species in right of way under the transmission lines wherever feasible may be carried out under project cost

2. The copies of the Forest Clearances and this order should be submitted to the all head of local bodies, Panchayats and Municipal bodies etc. for wide publicity.

3. The District Forest Officer, South, Belonia is also requested to submit the monitoring report time to the Nodal Officer, FCA after fulfillment of all conditions.

4. The handing over and taking certificate is to be submitted to the Nodal Officer, FCA along with GPS reading and polygon over the diverted land.
