The **Bid Fee** of Rs.1,000.00 (**Rupees One Thousand**) only, as paid electronically over the Online Payment facility, is **Non-Refundable** .

The Bidders' EMD amount shall be refunded to the bidder , after the "Award of Contract (AoC)" event is completed in the Tripura e-Procurement Portal, and only on receipt of "Performance Bank Guarantee" from the L1 Bidder in Physical Form .

Lowest Bidder (L1) have to deposit "Performance Bank Guarantee" within a date and time, as specified by the tender inviting authority through letter of Intent(LOI) to the L1 Bidder for depositing "Performance Bank Guarantee" in lieu of EMD Refund.

Online bidding shall be closed at 03:00 Pm of 20/11/2019.
