

Introduction

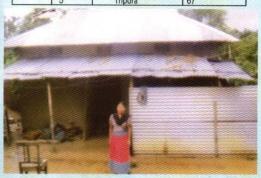

Swarnajayanti Gram SwarojgarYojana(SGSY)

In 1999 Swarnajayanti Gram Swarojgar Yojana (SGSY) was launched in the whole country along with Tripura. The people living below the Poverty line were organised to form Self Help Groups and to take up livelihood activities for their economic upliftment. The District Rural Development Agencies (DRDAs) are entrusted the responsibility of implementing the SGSY in Tripura. Summary of the achievements of this scheme till 31st March, 2013 are highlighted in the table given below.

The economic upliftment of the Self Help Groups (SHGs) under this scheme goes through three stages of creation:

- Group formation
- Capital formation through the revolving fund and skill development and
- Taking up of livelihood activity for income generation. Within first 6 months of formation of these groups, savings & interlending among the members has to be practised. The main objective behind this is to grow the habit of thrift & credit among the members. Based on the performances of the Groups in the first 6 months 1st Gradation is done. After successful completion of 1st Gradation an amount of Rs. 10,000/- from DRDA and Rs. 15,000/- from Bank i.e. a total of Rs. 25,000/- is given to the Groups as Revolving Fund (RF). Thus, the Savings of the Group+Interest+RF together comprises the financial basis of the SHG.

After 6 months of receiving the Revolving fund the 2nd Gradation of the SHGs is done to strengthen the relationship between the Bank & the SHGs.

Those SHGs which are able to successfully handle the thrift, credit & RF are considered for various income generating activities for their economic upliffment. The SHGs were assisted further through Bank Loans on submission of Project Proposals for taking up livelihood activities. They were also provided with subsidy up to a maximum limit of Rs. 1.25 Lakhs.

The SGSY is being substituted by National Rural Livelihood Mission (NRLM) from 2013-14. The ground preparatory work of Tripura Rural Livelihood Mission [TRLM]/ NRLM have already been done and it will be launched immediately in the state through which the SHGs formed under the SGSY will be largely benefitled.

Tripura State Support Project on SHGs(TSSPS)

The funding received from Government of India under SGSY was not enough to support the Self Help Groups in the State. In 2009-10 the State Government launched this project to overcome the hurdle posed by insufficient fund under SGSY. Under this project the SHGs which have successfully completed the 1st Gradation but could not be provided under SGSY were assisted with Rs. 25,000/- as Govt. component(at the rate of 4% interest) & Rs. 25,000/- as Bank component of startup soft loan i.e. a total of Rs. 50,000/-. Based on this fund the Groups take up livelihood activities. The SHGs were considered for 2nd Gradation after the loan amount is completely repaid. The achievements of this scheme till 31st March, 2013 are highlighted in the table given below.

Rural Development Department (Engineering Wing)

Rural development Department's (Erstwhile Community Development) Engineer Wing was set-up in the sixty decade of last century with one Assistant Engineer and couple of Overseers to look after Rural Water Supply. Details of the set-up of this Engineering Wing and their activities in different points of times are appended below:

During the last financial year (2012-13), R.D. Department incurred Rs. 1500.00 crores including MGNREGA scheme. Construction work worth Rs. 700.00 crores approximately against different schemes of R.D. Department and other line departments were successfully executed. Mode of execution of R.D. Department is departmental and consequently execution cost is 10-25% below than other agencies who execute the works through contractors. R.D Department ensures timely execution overall quality of the work. During the financial year, 2012-13, R.D. Department executed the largest project, Panchayat Raj Training Institute of Gomati District (execution cost exceeding Rs. 11.00 Crores) within sixteen months (Effective completon time). This is one of the aesthetic buildings of Tripura. R.D. Department is the first choice of all the departments/ PSUs of State who has no Engineering cadres/ adequate Engineering Cadres for execution of their construction wors.
