In the State Level Cultural Programme, minimum of 75% performers shall be selected from the locality where the event will be organized. The remaining 25% performers may be invited from different districts.

In District Level Cultural Programme, minimum of 75% performers shall be selected from all the sub-divisions under the district. The remaining 25% performers may be invited from different districts.

If "A" category artiste / authors @40% is not available in a District then "A" category artiste will be taken from other District.
