Terms of References for Hiring of Technical Support Agency (TSA) for developing broiler poultry value chain with 2000 women SHG members in 3 project districts of Tripura under Tripura Rural Livelihood Mission

1.0. Background

Broiler poultry are the most common and preferred livestock species in Tripura and reared by the weaker section of the total population particularly in the rural and hilly areas. Tribal & non-tribal all sorts of community have now been taken up broiler poultry as a source of income. The majority of growers are doing poultry mainly for meat purposes as a good source of animal origin protein. Broiler poultry rearing occupies an important position in the farming system in Tripura as it is closely interlinked with the other agricultural operation performed by the people for livelihood. The production system in the villages is very common. Feeding of balanced concentrate feed to broiler poultry is popular now days, the concentrates readily available in the market.

However, the size of the poultry farms varies significantly from small farms with just 200 birds to large farms of more than 50,000 birds. Most of the poultry farms are simple open sheds while only a few large poultry integrators have controlled-environment housing with automatic feeding and drinking systems. High capital costs and unreliable power supplies limit large scale adoption of the controlled environment poultry barn model in Tripura

Broiler poultry in Tripura is becomes a profitable commercial venture particularly for the women of the Self Help Group from small holder farming community. This, however, will require creating awareness and provide technical support for producing quality chicks, improve the production system and marketing system.

Looking the potential of broiler poultry as a livelihood of SHG women of the rural communities of TRLM project area, Tripura Rural Livelihood Mission (TRLM) is planning to develop the broiler poultry value chain in 3 project districts with the following broad objective

To developed 12 broiler poultry production clusters with total 2,000 farmers in 3 project districts of TRLM to increase the poultry production of the SHG women by 30% at the end of 3 years project period. To develop backward and furrowed linkages through PG & PO at the end of 3 years project period. Thus double the farmers' income of the broiler poultry growers at the end of 3years.

2.0 Scope of Work:

- To Increase broiler poultry production of 2000 small holder poultry farmers in existing farm involving local community to enhance current production practices and increase by production of farmers by minimum 30 percent of present production. This will enhance the income of the broiler poultry farming families by 30 percent of their present income from poultry.
- Build capacity of all livelihood coordinators/ field functionaries of TRLM & CSPs on broiler poultry so that they could effectively support in the Broiler poultry production

cluster.

- Build capacity of more than 50 Livestock CRPs on poultry so that they can provide support to farmers on improve broiler poultry production.
- Promote a common brand for inputs (Feeds, chicks etc) produced by the Framer Producer Companies and ensure proper marketing of the same.
- Promotion and strengthen of 3 Poultry Producer Companies in three project districts to support input and output marketing of poultry producers in the area
- Provide average minimum turnover of 3Cores, 5 Cores and 10 Cores in 1st, 2nd and 3rd years of the producers companies
- Promote at least 65 broiler poultry producer group at the village level with an average annual turnover of 20-30lakhs from input and output business at the end of 3years.
- Promote at least 3 (three) large size hatchery unit (10000 chick's at a time)
- Strengthen producer groups at the ground level
- Support in connecting the broiler poultry producers and PGs with existing PGs & FPOs of TRLM in the project district
- Provide technical support in ensuring on time vaccination, insurance and other critical issues
- Develop business plan for all the PGs promoted under this value chain development work.
