NOTIFICATION

Subject:- Appointment of State Chief Information Commissioner, Tripura Information Commission.


The Government of Tripura has constituted a body under the Right to Information Act, 2005 known as the Tripura Information Commission to exercise the powers conferred on and to perform the functions assigned to it under the Act. It is located in Agartala. The Commission shall have the State Chief Information Commissioner and up to one State Information Commissioner. **It is now proposed to appoint State Chief Information Commissioner in the Commission.**

2. The Act provides that the State Chief Information Commissioner and the State Information Commissioners shall be persons of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass media or administration and governance.

3. A State Chief Information Commissioner shall hold office for a term of 5 years from the date on which he enters upon his office or till he attains the age of 65 years, whichever is earlier. The salary and allowances payable to a State Chief Information Commissioner shall be the same as that of an Election Commissioner, subject to adjustment of the pensionary/retirement benefits availed by him/her, if any, in accordance with the provisions of the Act.

4. Persons fulfilling the criteria for appointment as State Chief Information Commissioner and interested for appointment to the post may send their particulars in the enclosed proforma by post to the Under Secretary, General Administration(AR) Department, New Capital Complex, Secretariat, Agartala, Tripura, Pin-799010 positively by 22nd April, 2019 or through e-mail at gaar.agt-tr@nic.in. Persons who are serving under the State/Central Government of any other organization, may send their particulars through proper channel.

5. This is issued with the approval of the Election Commission of India vide letter No.437/TP-HP/2019(MCC)-NES-1 dated 29-03-2019, which was conveyed by the Chief Electoral Officer, Tripura vide letter No.F.19(51)-CEO/CONDT/2019/9278-80 dated the 29th March,2019.
