

NOTIFICATION

In exercise of the power conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura is hereby pleased to make the following Rules regulating the method of Recruitment and educational and other qualification required for recruitment to the post of "Physical Education Teacher" Higher Secondary (XI-XII) under the Education (School) Department, Directorate of Secondary Education, Government of Tripura, namely:-

1. **Short title and commencement :-**

a) These Rules may be called "Recruitment Rules, 2022" for the post of "Physical Education Teacher" Higher Secondary (XI-XII) under the Education (School) Department, Directorate of Secondary Education.

b) They shall come into force on the date of their publication in the Official Gazette.
2. The name of the post (s) shall be specified in column-1 of the schedule annexed hereto.

3. **Number of Posts, classification and scale of pay :**

The number of the said post, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the said schedule annexed to this rules.

4. **Method of recruitment, age limit, qualification etc.:**

The method of recruitment to the said post, age limit, qualification and other matters relating to the said post shall be specified in columns 5 to 13 of the said schedule.

5. **Disqualification:- No person,**

a) who has entered into or contracted a marriage with a person having spouse living:

OR

b) Who, having a spouse living, has entered into or contracted a marriage with a person, shall be eligible for appointment to the said post:-
Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these Rule.

6. **Power of relax:-**

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, may relax any of the provisions of these Rules with respect to any class or category of persons.

7. Saving:-

i) Nothing in these Rules shall effect reservations, relaxation of age limit and other concessions required to be provided for the Schedule Castes, the Schedule Tribes, Ex-servicemen and other special categories of persons in accordance with the order issued by the State Government from time to time in this regard.


8. Interpretation:-

Recruitment Rules for the post of Physical Education Teacher under the Education (School) Department, Govt. of Tripura.

1	Name of the post	:-	"Physical Education Teacher" Higher Secondary (XI-XII)
2	Number of posts	:-	125 posts plus additional post when created
3	Classification	:-	Group- 'C' (Non-Gazetted)
4	Scale of pay	:-	Pay Band -2, Rs. 5,700 – 24,000/- Grade pay Rs. 4200/- Level-10 as per Tripura State Pay Matrix, 2018 subject to revision by the Government from time to time.
5	Method of recruitment whether by direct recruitment or by promotion or transfer on deputation and percentage of the vacancies to be filled by various methods.	:-	(a) 100% by direct recruitment through written selection test conducted by a Board constituted by the Government of Tripura. There is no provision of oral interview. (b) Minimum 50% mark is to be obtained in selection test.5% marks will be relaxed in case of SC/ST/PH candidates. (c) Fitness Test (Qualificatory in nature) - Physical (AAHPER) fitness test as per YAS norms and shall be conducted by YAS Department.
6	Age limit for direct recruitment.	:-	Up to 40 Years. Upper age limit is relaxable by 5 (five) years in case of SC/ST/PH and Government servant. Upper age limit is also relaxable for Ex-serviceman as per norms.
7	Educational and other qualification required for direct recruitment	:-	(a) Bachelor of Physical Education (B.P.Ed) OR Bachelor of Physical Education (BPE) OR Bachelor of Science (B.Sc) in health and physical Education and Degree in Sports with at least 55% as per National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009. OR At least 50% Marks in the B.P.Ed Degree / B.P.Ed (integrated) four years professional Degree in Accordance with the National Council for Teacher Education(Recognition Norms and Procedure)Regulations, 2007 Notified on 10 th December,2007). OR B.P.Ed with at least 55% marks OR B.P.E course (or its equivalent)of three years duration with at least 50% marks in accordance with the National Council for teacher Education(form of application for recognition, the time limit of submission of application, determination of norms and standards for recognition of teacher education programmes and permission to start new course or training)Regulations, 2002 notified on 13.11.2002. AND (b) Master of Physical Education (M.P.Ed) of at least two years duration from any National Council for Teacher Education Recognized Institution. Desirable:- Knowledge of Bengali or Kakkborok.
8	Whether age and Educational qualifications prescribed for direct recruitment will apply in case of promotion.	:-	Not Applicable
9	Whether Selection post or Non – Selection post	:-	Selection
10	Period of probation, if any	:-	2(two) years
11	In case of recruitment by promotion/ transfer on deputation, grades from which promotion/ transfer on deputation is to be made.	:-	Not Applicable
