NOTIFICATION

In exercise of the power conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura is hereby pleased to make the following Rules regulating the method of Recruitment and educational and other qualification required for recruitment to the post of **Special Educator** under the Education (School) Department, Directorate of Secondary Education, Government of Tripura, namely:-

1. Short title and commencement :-

- These Rules may be called "Recruitment Rules, 2022" for the post of Special Educator under the Education (School) Department, Directorate of Secondary Education,
- b) They shall come into force on the date of their publication in the Official Gazette.
- 2. The name of the post (s) shall be specified in column-1 of the schedule annexed hereto.

3. Number of Posts, classification and scale of pay:

The number of the said post, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the said schedule annexed to this rules.

4. Method of recruitment, age limit, qualification etc.:

The method of recruitment to the said post, age limit, qualification and other matters relating to the said post shall be specified in columns 5 to 13 of the said schedule.

Disqualification:- No person,

a) who has entered into or contracted a marriage with a person having spouse living:

b) Who, having a spouse living, has entered into or contracted a marriage with a person, shall be eligible for appointment to the said post:-

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these Rule.

Power of relax:-

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, may relax any of the provisions of these Rules with respect to any class or category of persons.

7 Javing:-

i) Nothing in these Rules shall effect reservations, relaxation of age limit and other concessions required to be provided for the Schedule Castes, the Schedule Tribes, Ex-servicemen and other special categories of persons in accordance with the order issued by the State Government from time to time in this regard.

8. Interpretation:-

If any question arises relating to the interpretation of these Rules, it shall refer to Education (School) Department, Directorate of Secondary Education, Government of Tripura, whose decision thereon shall be final.
