NOTIFICATION

In pursuance of the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi communication No.33/05/2019-EO(SM-I), dated 10-03-2019, the Governor is pleased to place the services of Shri Shantanu, IAS (TR:1997), Secretary, Govt. of Tripura at the disposal of the Government of India, Ministry of Defence, Department of Defence Production, New Delhi for appointment as Joint Secretary, Department of Defence Production on central deputation basis with effect from the date of assumption of the charge of the post.
