Notice Inviting Quotation (NIQ)

Sealed quotations are hereby invited from reputed IT Company/LLP/Proprietor/Authorised Dealer/Authorised Distributor who have been in the business of supplying of ICT equipment for past 3 years or more for Supply of **08 (eight) nos of Laptop Computer**. Quotation will be received at SMMU till **10.10./2025** upto **3:00 PM** in the office of the Chief Executive Officer, TRLM, PN Complex, Gurkhabasti, Pin-799010, Agartala Tripura (W) and to be opened in the same day, if possible. The specifications for the said Laptop Computer and format for submitting Quotation are enclosed at **Annexure-I & II**.

Terms and condition are given below:

1. An Earnest Money Deposit (EMD) amounting `20,000/- (Rupees Twenty thousand only) in the form of deposit at call or Draft Drawn in favour of "**Tripura Rural Livelihood Mission Society**" payable at Agartala from any Nationalised Bank/Tripura Gramin Bank/Tripura State Cooperative Bank shall be submitted along with the Sealed Quotation. The said EMD will be converted to security deposit for successful bidders who would be offered the work and will be refunded only after successful completion of the Warranty period and additional 1 month. For others the Earnest Money Deposit (EMD) shall be refunded.
2. Financial Bid will be opened only for those who qualify the technical parameter: -
 - a. EMD
 - b. Trade License
 - c. Pan Card
 - d. GST Registration
 - e. Experience Certificate (minimum 3 years).
 - f. Tax Clearance Certificate.
 - g. Self-declaration for the status of blacklisted or not.
3. The bidder in whose favour the supply order will be issued shall have to complete the delivery of Laptop Computer mentioned in **Annexure-I** within **15 (fifteen) days** of receiving of Supply Order. Incase of failure to supply the above mentioned Laptop Computer, the supply order shall be liable for cancellation or may forfeit the EMD fully or partially as per decision of the committee.
4. The materials are to be delivered in the office of the Chief Executive Officer, TRLM, PN Complex, Gurkhabasti, Pin-799010, Agartala Tripura (W) at free of cost.
5. Rate should be inclusive of all Taxes as applicable.
6. Rate should be quoted both digit and words.

7. Payment will be made only after successful delivery, installation of all required software and Quality Inspection done by the department.
8. Applicable taxes shall be recovered from the bill.
9. The bidder who will fulfil all the above mentioned criteria will be eligible for the bid. Selection will be based on the lowest one (L₁) basis.
10. If 2 (two) or more bidder quoted same rate (L₁) for any of the items, the supply order will be issued as per the decision of the purchase committee (based on Experience or Higher specifications).
11. The bidders shall dully sign the quotation papers.
12. The bidding process may be cancelled at any point of time without assigning any reason.
13. The undersign reserves the right to accept or reject any quotation including the lowest one without assigning any reason.
