2. The quotations will also be entertained by post provided those must be reached on or **before 15-12-2024 upto 3.00 PM.**
3. Quoted rates should be excluding of all taxes, duty, surcharge etc.

The interested quotationer may visit to Central Tea Processing Factory (CTPF)/ Brahmakunda Tea Processing Factory (BTPF) for lookout the exact condition of the tea processing machineries & Equipments before submission of the rates quotation for the maintenance / overhauling charges as machineries wise for CTPF and BTPF separately. Only accommodation for Service Engineer/Mechanic would be made available from this end at Factory premises during the period of above work. 5. The Quotationers must have previous experience and undertaken similar nature of work. In this regard authentic experience certificate / awarded work orders should be accompanied with the quotations.
