2. Tender will also be entertained by post provided those should reach on or before 24-06-2024 upto 3.00 PM.
3. Quoted rates should be inclusive of the cost required number of electronic color cylinder.
4. Quoted rates should be exclusive of all taxes, duty, surcharge etc.
5. Tenders should be accompanied by Earnest Money Deposit (EMD) OF Rs.10,000/- (Rupees ten thousand) only as "Demand Draft" from any Nationalized bank pledged in favour of Tripura Tea Development Corporation Ltd. Agartala.

The EMD of the successful bidder shall be retained as Security Deposit, which will be considered for releasing, subject to full and complete supply of above items as per terms and conditions of this tender notice.
