**Bid Fee/Tender Fee** is to be drawn in any Nationalized/ scheduled Bank guaranteed by the RBI in the shape of only **“Demand Draft”** in favour of the **Executive Engineer, R.D Santirbazar Division, Santirbazar, South Tripura**. Tender will be rejected or summarily treated as cancelled if the fee is deposited in any other form beside Demand Draft.

**Earnest Money (EMD)** is to be drawn separately in any Nationalized/ scheduled Bank guaranteed by the RBI in the shape of **“Deposit at call”** in favour of the **Executive Engineer, R.D Santirbazar Division, Santirbazar, South Tripura**.

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **Rs.1,000.00 (Rupees One thousand)** only, shall be accepted only in shape of **“Demand Draft”** which is Non-Refundable.

The Bidders will have to upload the scan copy of the drawn **“Demand Draft”(only for Bid Fee)/ “Deposit at call (only for EMD) ”** (as a single PDF file of 100 dpi resolution), against the related Bid fee & Earnest money, along with the bid.
