#### **Terms & Conditions of the Tender:**

- 1) The Tender should be submitted in two sealed envelopes for (a) Technical Bid and (b) Financial Bid.
- 2) The first sealed envelope shall super scribe as "**Technical Bid**" and the Second sealed envelope shall super scribe as "**Financial Bid**".
- 3) The Technical Bid will be open first. The Financial Bid will be opened for those bidders who will qualify the Technical Bid.
- 4) Bidder shall submit Valid Trade License, PAN Card, GST Registration Certificate, Bank details including A/C No along with IFSC Code in the Technical Bid envelop.
- 5) The bidders shall have to sign on all the documents along with seal. If any document found without any signature and seal, that document will not be considered for Technical Bid Evaluation.
- 6) Earnest Money Deposit (EMD) for an amount of Rs 65,000/- (Rupees sixty five thousand only) in the form of Demand Draft (DD) drawn from any Nationalized Bank should be deposited in favour of "Assistant Chief Electoral Officer (Computerization), O/o the CEO, Tripura, Agartala".
- 7) The EMD in the form of Demand Draft (in original) and the rate of each item shall be submitted in the Financial Bid Envelop.
- 8) Submission of EMD is applicable even for Co-operative Societies. Any bid made without submission of EMD will be treated as informal bid and will be summarily rejected.
- 9) Parties shall be selected separately for each item on the basis of lowest rate.
- 10) Quantity mentioned against items may increase or decrease.
- 11) After opening Financial Bid, if **L1 bidder(s)** backs out and fails to supply the materials, the matter will be taken up for blacklisting the concerned **L1 bidder**.
- 12) In case the selected bidder fails to supply all the items within the stipulated time, the EMD of the concerned bidder will be forfeited.
- 13) Quality of materials to be ensured & materials to be supplied strictly as per the specification of Election Commission of India. Any deviation will not be accepted. The sample of the item is annexed in **Annexure-'A'**.



- 17) EMD of all bidders other than that of the lowest bidder(s) would be released after placing of supply order. EMD of the lowest bidder(s) would be released after satisfactory supply of all the required items.
- 18) In case the selected bidder(s) fails to supply all the items within the stipulated time, the EMD of the concerned bidder will be forfeited.
- 19) Taxes would be deducted at source as per norms.
- 20) Any defective/substandard item to be replaced by the successful bidder within 3 (three) days at his own cost & risk.
- 21) Any incomplete tender would be treated as informal and will be summarily rejected.
