The rates to be paid for routine maintenance are indicated in the Bill of Quantities. Further, the payment for routine maintenance to the contractor shall be regulated based on his performance of maintenance activities.

11. The bids for the work shall remain valid for acceptance for a period not less than ninety days after the deadline date for bid submission.

12. Bidders may bid for any one or more of the works mentioned in the Table above.
