**NOTICE INVITING TENDER (NIT)**

On behalf of Governor of Tripura, the undersigned invites sealed rate quotations in the plain paper from the interested, experienced and registered Bidders/Vender/SHGs for **installation of RO Purifier (RO+UV+TDS Controller) & water chiller** (capacity not less than 150 ltrs.) under MPLADS Scheme, Bamutia RD Block during 2023-24 financial year. The sealed rate quotation should reach to the Office of the Block Development Officer Bamutia RD Block, West Tripura latest by 24/07/2023 by 4pm.

The items and specification as below may be obtained from the office of the undersigned on any working days during the bidding period. The intending bidder shall quote rates as per the following format:-

If the last date of tender dropping /opening of tender are paralyzed due to any unforeseen reason, the next working day will be the last date of dropping /opening of tender box.

Security Deposit in the shape of D-call for an amount of **Rs.2,000/- (Rupees two thousand) only** should be deposited in favour of **Block Development Officer (BDO) , Bamutia RD Block** from any scheduled bank guaranteed by the RBI. Security Deposit in cash or in any other form shall not be accepted and without security deposit, the submitted rate quotation shall be summarily rejected.

The materials shall be of the above mentioned specifications only. The intending bidder should quote the rate in prescribed format given above along with copy of CRC/PRTC, PAN Card and Aadhar Card, trade license, GST registration certificate, experience certificate (if any) etc. for evidence of valid bidder. Any incomplete tender will summarily be rejected. The undersigned reserves the right to reject or accept part or full of this quotation including the lowest bidder without assigning any reason thereof.

1. The lowest quoted unit price against each item will be taken into account for selection of bidder.
2. The sealed quotation should reach to the O/O the Block Development Officer (BDO), Bamutia RD Block, west Tripura on or before 4 pm of 24/07/2023. No quotation will accept after the specific time for any reasons.
3. The rate contract shall be valid up to 2023-24 financial year. Quantity of the product may be increase.
4. The rate should include manufacturing, supplying, carrying including loading/unloading & installation **RO Purifier (RO+UV+TDS Controller) & water chiller** at work site.
5. Supply of materials as per specification with indication details in supply order.
6. Rate should be quoted in both figure and works inclusive of all inevitable Taxes, manufacturing, Supplying, carrying including loading/unloading & installation.
7. The rate once approved shall not be increased for any reason whatsoever or under any Circumstance during the contract period.
