

Earnest Money & Tender fee is to be deposited through online payment gateway system in the tender portal.

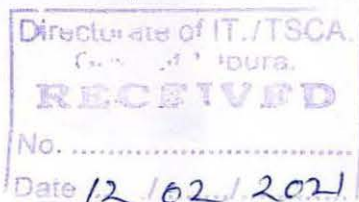


