8. Only online submission of bids is permitted, therefore; bids must be submitted online on website www.pmgstenderstrp.gov.in The technical qualification part of the bids will be opened online at **1530 Hours on 25/09/2019** (if possible) by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day at the same time.

9. **The bidder is not required to quote his rate for routine maintenance.** The cost of annual maintenance for five year shall be fixed and pre declared by the department. The rates to be paid for routine maintenance are indicated in the Bill of Quantities. Further, the payment for routine maintenance to the contractor shall be regulated based on his performance of maintenance activities.

10. The bids for the work shall remain valid for acceptance for a period not less than ninety days after the deadline date for bid submission.

11. Bidders may bid for any one or more of the works mentioned in the Table above. To qualify for a package of contracts made up of this and other contracts for which bids are invited in the same NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
