**NOTICE INVITING EXPRESSION OF INTEREST FOR INTERNATIONAL BUS
SERVICE OPERATION**

The undersigned on behalf of Tripura Road Transport Corporation, Agartala is hereby invites sealed cover **EXPRESSION OF INTEREST** from the Interested, Resourceful, Financially sound reputed experienced Passenger Transport International Bus Service Operator / Agency, Passenger Transport Interstate Bus Service Operator of International and Interstate Passenger Bus Service Operation or Experienced in Bus Ticket Booking in International Bus Service Operation of having Indian National by way of utilizing Modern Volvo Bus (A.C) of TRTC for quoting / offering their rates for Operation and Maintenance of both bus(s) & bus route in the bus route of **AGARTALA TO KOLKATA VIA DHAKA (BANGLADESH) AND VICE VERSA** for the contract period of 3(three) years from their own cost / expenses under TRTC paying monthly rental fee / charge to TRTC per bus per month per route basis on such Terms & condition as detailed / furnished in the EOI document of TRTC which will be available for **Collection** from the office of Managing Director / Traffic Manager (Bus), TRTC, Krishnanagar, Agartala and office of the Deputy Resident Commissioner, Tripura Bhavan, Salt Lake, Kolkata West Bengal against payment of **non-refundable** sum of **Rs.10,000/-(Rupees Ten thousand)** only for each set of EOI document in the shape of Bank Demand Draft / Cash during the period from **25/09/2019 to 11/10/2019** on all working days during office hours only on application.

The sealed cover duly filled in EOI document along with required EMD & other related documents super scribing the EOI Notice no & date in covering envelop shall be **Dropped** in the Tender Box as would be provided in the office of the MD, TRTC Krishnanagar, Agartala on **16/10/2019** from **11 AM to 3PM**, only and the Tender box shall be **Opened** on **17/10/2019** at **4 PM** sharp in the same places, if possible.

The selected Tenderer / Bidder / Bus Operator shall bear all sorts of expenses in connection with operation and maintenance of both bus(s) & bus routes in the bus route of Agartala to Kolkata via Dhaka (Bangladesh) and vice versa including the cost / expenses of any type of repairing / maintenance of Volvo Bus (minor & major in respect of mechanical, electrical, electronic & body side at any stage for any purposes), payment of operational expenses like salary / wages etc. of crew member of buses, fuel, tyre, battery etc. & running day to day repairing cost, payment of comprehensive Insurance coverage, road tax, route permit, toll tax etc. accidental repairing cost etc. and in turn they shall be allowed to collect the approved bus fare from the authorized travelling passenger in this regards.

Earlier EOI vide No.F.7(3)-MD/TRTC/VOLVO BUS/2019/21, dated 27/05/2019 had been invited by TRTC for the same purposes, is hereby cancelled in all respect.

Any refusal / non-compliance / non responding etc. in any manner on the part of the successful / selected Tenderer / Bidder / Bus Operator as against the issuance of offer of acceptance of rates by TRTC followed by finalization of EOI / Bid / Acceptance of rates & others by TRTC, the entire EMD (earnest money deposit) as deposited shall be forfeited accordingly as per discretion of MD, TRTC, treating the matter as dropped and cancelled of said EOI / Bid / offer etc. of the said Tenderer / Bidder too. Forfeiture EMD shall also be made in event of any claim / request for withdrawal of EOI / Bid after the same is submitted or accepted.

The Managing Director, TRTC reserves every right to accept or reject any EOI / BID in part or full, even the highest quoted rate and even issuance of offer and during the contract period without assigning any reason thereof in this regards at any stage and the decision of MD, TRTC for the above purposes shall be final and binding upon the Bidders / Bus Operators, as may relate.
