



**TERMS & CONDITIONS FOR PURCHASE OF CHEMICALS AND REAGENTS FOR THE COLLEGE OF VETERINARY SCIENCES & A.H., R.K.NAGAR WEST TRIPURA DURING THE YEAR 2021-22.**

Notice inviting tender (NIT) will be received by speed post/Registered Post/Courier services only in sealed cover addressed to "The Principal, C. V. Sc & A.H. Government of Tripura, R. K. Nagar, West Tripura Pin-799008" on or **before 4 P.M. of 18/05/2021** NIT received after the aforesaid date and hours shall be rejected. The Principal, C. V. Sc & A.H. shall not remain responsible for any postal delay. Tenderers are requested to provide detailed address along with phone, Fax Number and S.T.D code number for communication.

- 1) The cost of blank tender form is Rs. 300/- (Rupees three hundred, Non refundable) which may be paid in the form of DD of any Nationalized bank in favour of "The Principal, C. V. Sc & A.H. R. K. Nagar, West Tripura" payable at 'Agartala'. The tenderers who will use downloaded form from the website also shall have to pay the cost of the tender form Rs. 300/- (Rupees three hundred, Non refundable) only separately in the form of DD of any Nationalized bank in the name of Principal, College of Veterinary Sciences & Animal Husbandry, R.K. Nagar, payable at Agartala. Downloaded tender form received without DD of Rs. 300/- shall be rejected. No blank tender form shall be supplied either by post or courier to the tenderers. While quoting the rate, the tenderer must mention the serial no of the items as per list (at Annexure A) provided by the college along with tender.
- 2) On the top left side of the sealed tender N.I.T number, date, due date of opening should be mentioned. Tenders will be opened on the next working day of last date of receipt, if possible. Tenderer or their representative may remain present at the time of opening of the tender.
- 3) The interested bidders/tenderer shall submit the bids in 2 parts, i.e. 'Technical Bid (**A envelope**) and 'Financial Bid' (**B envelope**). The 2 bids A & B envelopes should be put in 2 separate sealed envelopes, indicating clearly on the cover as technical bid and other one is the financial bid. The 2 envelopes shall be placed inside a large sealed cover and the same may be submitted.

**The technical Bid** shall contain all details regarding the items offered by the bidder, compliances of terms and conditions, submission of documents, products catalogues & earnest money etc. In other words everything except the rate offered. **The Financial bid** shall contain only the rate offered by the bidder. The technical bids will be opened first and the bidder will be short listed on the basis of fulfillment of requirements as per terms & conditions. Thereafter, financial bids of only short listed bidders will be opened and **the lowest bidders will be selected and selection of item is subject to recommendation of the technical committee constituted by the Principal, C. V. Sc & A.H.**



- 4) While quoting rate, the tenderers must mention the Serial No. of the item of tender lists as, provided by the College only along with tender. Items should be supplied by the authorized distributor/dealers/agency/suppliers of manufacturing firm of chemicals and reagents.
- 5) As the items are clearly divisible and distinguishable, the successful firms/tenderers shall be selected separately for each item.
- 6) The supply has to be executed within 30 (thirty) days from the date of issue of the supply order. In case, failure of supply the ordered item/items in full within stipulated period, both the Earnest money and security deposit money are likely to be forfeited without further correspondence.
- 7) G.S.T & Income tax will be deducted from the bill as per State Government rules.
- 8) In case of tenderers whose rates are accepted, as per terms & conditions of the tender shall duly execute the supply.
- 9) The rates should be quoted both in figures and words clearly. GST will be charged extra as per Govt rule. The rate should be quoted in Indian currency only.
- 10) The supply order will be issued once/at a time or in phased manner as per requirement. Quantity may increase or decrease depending on requirement.
- 11) The lowest rate quoted by the tenderer will be determined on the basis of comparison of basic rate (i.e. excluding GST).
- 12) The following self certified/self attested documents should be submitted along with the tender:-
  - (A). Up to date Tax Clearance Certificate (T C C): which will include: -
    - 1) GST Registration certificate.
    - (ii) GST Clearance Certificate (Sale tax clearance).
    - (iii) PAN Card.
  - (B) Other Certificates
    - (i) Up to date valid Trade License certificate of authorized local Distributors / stockiest / dealers / agencies / suppliers of manufacturing firms (Authorized in case of authorized Distributor-cum-tenderer).




(ii) Earnest money (E/M) for an amount Rs. 5,000/- (Rupees five thousand) only whichever is less shall have to be paid as fresh deposit at Call (D-Call) /Bank Draft of any nationalized Bank of India, drawn in favour of **the Principal, College of Veterinary Sciences & A.H., R. K. Nagar** payable at **Agartala** has to be deposited along with the tender. In case of un-successful tenderers the Earnest Money deposit (EMD) will be released after finalization of the tender, while in case of successful tenderers/ suppliers the Earnest Money so deposited (EMD) will be released after successful completion of supply.

- 13) EMD shall not be applicable in case of Govt. organization/Public Sector undertaking. However documentary proof has to be submitted by the bidder.

- 15) The supplier, who is not a manufacturer or who quoted rate for the product in favour of the manufacturer shall furnish a letter of authority from their behalf. Such supplier/tenderer shall also furnish an undertaking that in the event of acceptance of the rate he will supply the products of the manufacturer for which he quoted the rate.
- 16) No. Insurance charge is admissible and the successful tenderer/supplier will be responsible for any breakage, damage and loss in transit on the way to destination.
- 17) Any default or breach of contract by the suppliers will be subject to forfeiture of earnest money & will be considered as blacklisted /delisted for participating future tender as per discretion of the Principal, College of Veterinary Sciences & A.H., R.K. Nagar, Government of Tripura.
- 18) The Principal, College of Veterinary Sciences & A.H., R. K. Nagar, Government of Tripura, reserves the right to accept or reject any part of/all tender/tenderers without assigning any reason thereof .
- 19) The Principal, College of Veterinary Sciences & A.H., R.K. Nagar, Govt. of Tripura, reserves the right to terminate the contract or cancel the acceptance of rate or supply order at any time unilaterally without any notice before the expiry of the period for which the rates are now invited.
- 20) In case of any legal dispute the jurisdiction will be the High Court of Tripura, Agartala.
- 21) Payment of the successful tenderer shall be made by bill basis only after Completion of supply of the item/items as ordered for. No advance payment will be entertained.
- 22) **The rates will remain valid for a period of 01 (one) year from the date of approval.** No interim revision/Enhancement of rates will be entertained except imposition of any levy or increase in existing levy by the Government.



- 23) Selection of items is subject to recommendation of the approved technical committee Constituted therefore.
- 24) A duly signed copy of terms & condition of the Principal, College of Veterinary Sciences & A.H., R.K. Nagar to be returned by the tenderers as a token of acceptance of the Departmental terms & conditions.
