

## Notice inviting application for participation in the performance trial of Hybrid Paddy during Kharif' 2024

Applications are hereby invited from the interested seed producing companies/ authorized dealer for participation in the performance trial of hybrid paddy to be conducted at State Agriculture Research Station (SARS), A. D. Nagar and in a suitable Farmer's field in the State of Tripura during Kharif, 2024.

## Terms & Conditions

1. Applications along with duly filled in format (A) and copies of related technical information Research & Development (R & D) division of the participating companies about the suitability of hybrid paddy under acidic soil and agro-climatic condition of North Eastern Region of India will be received upto 15<sup>th</sup> May'2024 5.00 PM.

2. Only one new hybrid variety of a producing farm will be allowed. Yield performance trial of maximum 10 (Ten) samples of Hybrid paddy shall be put on trial during Kharif season, 2024 on 'first-come, first-served basis'.

3. Only those Hybrid Paddy varieties falling within 5 (Five) years of notification by the Government of India will be considered for inclusion in the variety trial programmes the Department.

4. A trial committee shall scrutinize the applications, duly field in formats and copies of related technical information in support of Hybrid paddy and also prepare a list of prospective hybrid for inclusion in the trial programme based Research & Development (R & D) division.

5. The shortlisted companies/ their authorised local dealers shall have to deposit trial fees in advance by Cash/ Cheque/ Draft/ RTGS @ Rs. 3,000/- only, each for conducting 2 (two) simultaneous trials of each hybrid at SARS as well as selected farmer's field with 2 (two) separate seed samples of 1 (one) kg ach for both the trials by 15<sup>th</sup> May' 2024 5.00 PM.

6. The trial committee will thoroughly scrutinize the results of trial and identify the best performing hybrids from among the tested hybrids based on the following norms.

- The candidate should be uniform for impotent characters like plant height, maturity etc.
- II. The candidate hybrid must be stable for the key trials such as resistance to a specific insect pests & diseases.
- III. The candidate hybrids should possess some distinct diagnostic features including yield attributing parameter in respect a grain yield making them different/ identifiable from extant hybrid.

7. The trial committee may exclude any hybrid from the subsequent trial programme if the yield of tested hybrid fails to give 10% yield advantage over the yield of popular check variety.

8. The undersigned reserve the right not to issue any performance report in favour of the candidate hybrid, if there is any damage to the crop at any stage of growth due to natural calamities.
