Bidders are allowed to bid 24x7 until the time of Bid closing, with option for Re-Submission, wherein only their latest submitted Bid would be considered for evaluation. Bidder should not be blacklisted by any central/state Government Department/agency regarding quality compromise or any other reason as on closing date of tender. Bidders having any ongoing litigation with any department / agency of central / state Government are also barred from participation in the tender.

Bid Fee and Earnest Money Deposit are to be paid electronically over the Online Payment facility provided in the Portal, **any time after Bid Submission Starting Date & before Bid Submission Ending Date**, using Net Banking. The Bid Fee should be paid electronically over the Online Payment facility as indicated against each work in accordance to the tender value, is **Non-Refundable** and to be **deposited to the Government account** automatically as revenue. The bidders EMD amount shall be refunded to the bidder after the “Award of Contract (AoC)” event is completed in the Tripura e-Procurement portal and only on receipt of “Performance Bank Guarantee” from the L1 bidder in physical form. Lowest Bidder (L1) have to deposit “Performance Bank Guarantee” within a date and time as specified by the tender inviting authority through letter of intent (LOI) to the L1 bidder for depositing “Performance Bank Guarantee” in lieu of EMD Refund.

Tender must be uploaded in two-bid system-a) Technical and General bid, b) Financial Bid. Bidder will participate in tender online through website <https://tripuratenders.gov.in> for which they have to register/enroll their name through the same website. No provision will be there to drop tender physically (hard copy).

Pre-bid meeting will be held on 31/03/2021 at 03:00 PM. Technical bid of the tender will be opened on 12/04/2021 at 3:30 PM if possible. If the last date of submission and date of opening happens to be a holiday or office work is affected due to any unforeseen reason, the date of submission /opening will be on next working day.


