On behalf of the Chairperson, Teliamura Municipal Council, the undersigned hereby invites sealed Quotation for supply, installation and Commissioning of 1 (one) unit **Silent Diesel Generator Set** for the newly constructed Electric Crematorium at Teliamura under Teliamura Municipal Council in Khowai District, Tripura from the reputed firm, bonafide and authorized registered Supplier/Dealer/Agency.  (i) Eligible bidders should participate in Tender online through website <u>https://tripuratenders.gov.in</u> (for online bidding) for which they have to register / enroll their name through the said website. Bidders blacklisted by Central/State Govt will not be permitted to participate.

(ii) Sealed envelope quotation may also be submitted (for offline bidding) writing specified rate in figure & words (in the format **ANNEXURE-A**) consisting following documents (in the format **ANNEXURE-B**): **a**) Copy of Trade License **b**) Copy of GST Registration and uptodate GST filing certificate **c**) Copy of PAN Card **d**) Working experience certificate **e**) Uptodate IT clearance certificate **f**) In case of SHG/PACS/Co-operative Society Ltd., registration certificate **g**) Bank AC details h) Nationality Proof (Citizenship/PRTC/EPIC) of the intending bidder, not required in case of SHG/PACS/LAMPS/Co-operative Society Ltd etc.

2) The job/supply order is comprising of *Supply, installation* & *Commissioning of* Silent Diesel Generator for newly constructed Electric Crematorium, Teliamura, inclusive of cost of Transportation upto the site of the Crematorium, packaging, transit insurance,

loading & unloading of the consignment and supply of required Wire (best quality to the satisfaction of concerned Govt. Agency/Deptt.) for doing wiring work for commissioning of the DG Set.

- 3) The above mentioned item/(s) should be in good condition and maintaining best quality as per specification and should be in capacity for the purpose cited. No compromise will be entertained with the quality / brand of items. In this regard, decision of concerned Govt. Deptt. /Agency shall be final and binding upon the supplier.
- 4) Bidding / Sealed quotation should accompany EMD @2% of the rate quoted through Demand Draft to be drawn from any nationalized bank or Private Bank (ICICI/HDFC) in favour of the Chief Executive Officer, Teliamura Municipal Council.
- 5) The successful Tenderer / Bidder shall deposit 5% of the quoted rate as SECURITY MONEY through Demand Draft to be drawn from any nationalized bank or Private Bank (ICICI/HDFC) in favour of the Chief Executive Officer, Teliamura Municipal Council within 7 (seven) days of having the Supply Order. The said security money will be released after 3 (three) months subject to full & complete supply, installation and commissioning in healthy condition in smooth manner without any interruption and as per T&C of this Tender/subsequent Agreement/satisfaction of the Bid issuing authority, and also smooth functioning of the supplied machine during such 3 (three) months. If the successful bidder makes prayer, the CEO TMC may consider adjustment of the amount of EMD with the Security Money to be deposited or if prayed for, such Security Money can be adjusted with final bill also.
- 6) The item/works should be supplied/carried out within next 30 (Thirty) days from the date of receipt of the supply / work order, if so considered. Penalty @0.05% per day would be imposed for any sort of delay beyond reasonable justification and except natural calamities as determined by the CEO, TMC and be adjusted with the final bill.
- 7) No advance payment shall be made. Payment will be made after successful completion of supply/installation/commissioning of the DG Set with full satisfaction of the authority and taxes /duties as applicable shall be deducted from the bills at source unless authenticated documents are to be produced.
- 8) The undersigned reserve the right to accept or reject any quotation, extend the validity for dropping/bidding period of Tender or cancel Tender at any time without assigning any reason thereof.
- 9) A separate Agreement with the 1st lowest bidder will be signed after finalization of rate and issuance of work order in respect of Operation & Maintenance of the machine/(s) including training of Municipal appointed staffs for first 01 (One) month after installation and starting of operation.
- 10)The lowest bidder / supplier shall provide all sorts of maintenance of the DG Set for first 01 (One) year in case of any technical fault etc. **free of cost.**
- 11)Carrying, Loading & unloading and installation to be done by the lowest bidders / supplier in his own cost as a part of the job description stated at SI. No. 2 above.
- 12)All participating Tenderer/bidder should have previous experience of executing similar nature of supply/job with proven records to be submitted alongwith the tender / bid.
- 13)No condition of any bidder shall be entertained.
- 14) If office remains closed on the last date of the Tender as notified due to unforeseen reason or circumstances, the tender may be dropped (in case of offline) by the same time on the next working day.

- 15)Any enhancement of rate within the validity period of contract will not be considered unless there is imposition of any levy or increase of existing levy by the Govt. otherwise such request will lead to cancellation of the order.
- 16)All disputes shall be under the jurisdiction of Courts in Khowai District, Tripura only.
