The tender box under lock & key will be kept open for dropping of tender by the intending bidder in the office of the undersigned from 03-06-2019 to 10-06-2019 from 10:00 am to 3:00 pm except Govt. holidays and the box will be opened on the last day i.e 10-06-2019 at 4:00 pm, if possible in presence of the interested suppliers who have participated in the quotation. If the last date of tender dropping/ opening of tender are paralyzed due to any unforeseen reason, the next working day will be the last date of dropping/ opening of tender box.

The quality of articles should be in good condition. The intending bidder should quote the rate as prescribed format given below along with copy of CRC/PRTC, PAN Card, VAT clearance certificate, tax clearance as evidence of valid bidder and permanent resident of Tripura. Any incomplete tender will summarily be rejected.

The Following Terms and Condition shall apply:-

- The scaled quotation should reach to the o/o the Block Development Officer, Teliamura RD Block, Khowai District, Tripura on or before 3:00 pm of 10-06-2019. The applicant/agency should be a reputed manufacturing company/ supplier of the items sought above.
- 2. The rates should be quoted for each brand and model separately. The rates shall include supply, installation and commissioning of Publicity Equipments
- 3. The sealed cover envelop shall be superscripted by the expression " QUOTATION FOR SUPPLY OF PHOTOCOPIER MACHINE TO TELIAMURA RD BLOCK".

- 4. The agency must be registered under GST. Copy of GST registration should be submitted. The agency must have PAN linked bank account which is preferably AADHAR seeded. All these mandatory document should be invariably submitted which shall be checked for authenticity at the time of opening tender.
- 5. Rate should be quoted (both figure and word) for each item separately inclusive of all inevitable taxes, transportation charge, cost of fitting and fixing & other service charges, if any.
- 6. Supply of the Photocopier machine should be completed within 7(seven) days from the date of receipt of supply order or placing of supply order. In case, the quality of the said items supplied are found sub-standard / inferior, the supplier shall liable to replace such materials at their own cost.
- 7. The rates once approved shall not be increased for any reason whatsoever or under any circumstance during the contract period.
- 8. Payment will be made on production of bills in triplicate after successful completion of supply within the stipulated date.
- 9. The undersigned reserves the right to reject or accept part or full quotation including the lowest one without assigning any reason.
- 10. Any tender not complying with required terms & conditions as stated above will be treated as informal.
- 11. Necessary taxes would be deducted as applicable as per govt. norms.
- 12. In case of legal dispute the jurisdiction will be the High Court of Tripura.
- 13. Terms & condition incorporated in the SNIT shall form a part of the agreement.
