#### 1. Scope:

The Notice Inviting Tender is issued for procurement of Polyester Based Tamper Evident Security Holograms produced using stamping foil which can be identified by the user with naked eyes and cannot be counterfeited for affixation on liquor/beer/wine bottles and any other product as and when decided, including cans sold in the State of Tripura under annual rate contract system for supply to the Commissioner of Excise, Government of Tripura, P.N. Complex, Gurkhabasti, Agartala-799006.

#### 2. Information to the Bidder:

- (i) Though adequate care has been taken in the preparation of this Tender document, the tenderer should satisfy himself that the documents furnished in response to this notice are complete in all respects. Intimation of discrepancy, if any, should be given to Excise Organization (Finance Department) immediately. If the Excise Organization (Finance Department) receives no intimation, it shall be deemed that the tenderer is satisfied that the Tender document is complete in all respects.
- (ii) None need to participate in the tender who does not accept/fulfil the terms & conditions indicated below.

#### 3. Guidelines for Technical & Financial Bid

- (i) The bids are invited under single stage two bid system namely: (1) Technical Bid and (2) Financial Bid. After receipt of tenders, Technical Bid will consist of qualification criteria and security specifications & features of hologram. Technical Bid will be opened first and will be evaluated as per specifications and all terms and conditions. Thereafter, Financial Bids will be opened only for those bidders whose bids were found to be technically qualified.
- (ii) During opening of Technical Bid, the tenderer or its authorised representatives must come along with all original documents/invoice copies and other papers alongwith samples of the hologram as per security specifications & features mentioned in the NIT, to prove the authenticity and security specifications & features of the hologram.

#### 4. Qualification Criteria (Technical Bid)

#### Part- I

- (a) List of the documents to be scanned and uploaded within the period of bid submission date:
  - (i) Tender fee of Rs. 5,000/- and Testing Charge of Rs. 20,000/- (both non-refundable) and Earnest Money Deposit (EMD) of Rs. 8,64,000/- (refundable) to be deposited through online mode in the payment gateway integrated with the e-Procurement portal https://tripuratenders.gov.in as per the Finance Department Memorandum No. No.F.10(SAB 1) /FIN(EXPDT-1)/2019/956-1100 dated 17.08.2019 at Annexure-III.
  - (ii) Tenderer should be a profit making organization and should have minimum turnover of Rs.4.00 Crore from Polyester based tamper evident security hologram during last three financial years (2017-18, 2018-19 and 2019-20). Copies of audited balance sheet along with a Chartered Accountant's Certificate in support of this claim must be submitted.

- (iii) The tenderer must be a manufacturer of Polyester based tamper evident security hologram and self-certified copy of manufacturing certificate/license issued by competent authority must be submitted. No authorised traders/agents of manufacturer shall be considered.
- (iv) The tenderer must possess in his premises all relevant and capable machines specified as compulsory in point 6, 7 & 8 of Annexure- I of this tender document. All the machines must be installed within the premises of the tenderer and under a secured environment. The successful bidder shall not be allowed to subcontract or sublet any work or part thereof to any outside agency. Tenderer shall have to submit an affidavit on Non-Judicial Stamp paper stating that all compulsory facilities, equipment (Plant & Machinery) and processes shall be carried out, in-house and none will be subcontracted or sublet to any outside agency.
- (v) Copy of PAN and Income Tax returns for the last 3(three) years of the tenderer is to be provided.
- (vi) GST Registration and Returns for the last 2(two) years of the bidder to be provided.
- (vii) List of Directors/Partners with address and contact number to be provided on Company/Firm letter head.
- (viii) The tenderer must be a member of International Hologram Manufacturers Association (IHMA) and Hologram Manufacturers' Association of India (HoMAI). Copy of membership certificate for current year should be submitted.
- (ix) Complete details of the different manufacturing facilities, plant & machinery, security equipment, manpower etc. as per Annexure-I should be submitted.
- (x) The tenderer must have experience of manufacturing and supplying Polyester based tamper evident security hologram to at least one State Excise Department in last three financial years (2017-18, 2018-19 and 2019-20). Copies of all required documents like Purchase order, machines etc. to be submitted to prove experience.
- (xi) Declaration as per Annexure-II and affidavit stating that the firm is not blacklisted by any State/UT or Central Government.
- (xii) Complete details of Security specifications and features should be uploaded as per Point-5 of the NIT at Part-II indicating -
  - Master Origination System & Holographic features.
  - Non-Holographic Features.
  - Other Security Features of Hologram.

#### (b) List of samples to be submitted physically:

(i) The tenderer shall submit 4(four) artwork options as per the security specifications and features as mentioned in Part-II of the DNIT. The submission of the samples of artwork options to the office of the Commissionerate of Excise, P.N. Complex, Gurkhabasti, Agartala should be within the tender closing date & time. The samples may be submitted either by registered post or by any authorised personnel of the tenderer physically at the office of the Commissionerate of Excise, P.N. Complex, Gurkhabasti, Agartala.

(ii) 1 (one) spool of hologram samples containing minimum 10,000 holograms of size 80 mm (length) X 15 mm (width) with prescribed specification as mentioned should also be submitted physically as mentioned above.

#### 6. Qualification criteria (Financial Bid)

#### 7. Terms and Conditions

- (i) The EMD to be deposited through online mode in the payment gateway integrated with the e-Procurement portal https://tripuratenders.gov.in as per Finance Department Memorandum No.F.10(SAB 1)/FIN(EXPDT-1)/2019/956-1100 dated 17.08.2019 which has been annexed at Annexure-III. In case of any kind of surrender/withdrawal of tender is made by bidders after opening of tender, the EMD as deposited by the bidder at the time of submission of tender shall be forfeited as per manner provided in the aforesaid Memo.
- (ii) Performance security of Rs.43,20,000/- (Rupees forty three lakhs twenty thousand) to be submitted in form of account payee demand draft or fixed deposit receipt from a commercial bank or bank guarantee issued / confirmed from any of the commercial bank in India in an acceptable form, safeguarding purchasers interest in all respects. Performance security to be furnished by a specified date after issuance of Letter of Intent (LoI) to the L1 bidder (generally 14 days after issuance of LoI or as specified in LoI). The performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations. The Performance security will be forfeited and credited to the Procuring Entity's account in the event of
  - a. The supply in part or in full are not effected in accordance with the delivery schedule.

- b. In event of rejection of consignments on account of sub-standard product and infringement of security requirements, not in conformity with the specifications.
- c. Any act of breach of contract by the contractor
- d. In case the tenderer whose tender is accepted fails to deposit the security deposit and execute the agreement as required by the Commissioner of Excise within the date as specified in LoI. In such case, his tender will be rejected outright and EMD forfeited.

The Performance security shall be refunded to the successful bidder / contractor without interest, after he duly performs and completes the contract in all respects but not later than 60 days of completion of all such obligations including the warranty under the contract.

- (iii) The Financial bid once quoted must include all charges (inclusive of all taxes) till the time the holograms are delivered to the office of the Commissioner of Excise, Government of Tripura, P.N. Complex, Gurkhabasti, Agartala- 799006. The prices should be inclusive of all taxes applicable as on date as per Government rules.
- (iv) The Financial bid once accepted by the Commissioner of Excise, Government of Tripura shall remain valid till the successful execution of the order and till the supplies are fully affected and accepted. The Excise department shall not entertain any decrease or increase in the rates during the period of execution.
- (v) The quantity of procurement of hologram labels in a year shall be around 5,00,00,000 (Five Crore).
- (vi) The result of bids evaluation can be seen in the e-procurement application <a href="https://tripuratenders.gov.in">https://tripuratenders.gov.in</a> by all the bidders who participated in the Bid.
- (vii) The Commissioner of Excise, Government of Tripura is not bound to accept the lowest tender and reserves the right to accept or reject any tender/bid without assigning any reason thereof.
- (viii) If required, the Department may carry out physical inspection of the manufacturer's premises to ascertain the technical capability of the tenderer, the facilities available and manufacturing capacity to decide on the eligibility of the tenderer. During such visits, all the machines, processes and other inter-mediatory processes must be in working and running condition.
- (ix) Full name, address and contact details of the representative who would be attending the opening of tender on behalf of the tenderer should be provided on company letter head. A proper Authorisation letter on Rs.100/- non-judicial stamp paper should be provided in favour of Representative/Authorised Signatory by the tenderer.
  - (x) The successful tenderer has to register the image as approved by the Commissioner of Excise, Government of Tripura with the IHMA image register.
  - (xi) Successful tenderer must obtain approval of Art work from the Commissioner of Excise, Government of Tripura incorporating all the different features of hologram, prior to commencing production.
  - (xii) The tenderer should ensure to the entire satisfaction of the Commissioner of Excise, Government of Tripura that the MASTER of the hologram shall be kept in safe custody and is not tampered with, lost or damaged. In case the MASTER is lost or damaged or tampered, the Security Money shall be forfeited with the cost of the MASTER by the Department. The MASTER shall be the property of the Excise Department and hence

the successful tenderer shall return the original after completion of the order. The Commissioner of Excise can also ask the successful tenderer to keep the MASTER with him in safe custody by signing a Custodian bond or arrangement shall be done for joint lock and key system of the MASTER at appropriate safe location as deemed fit.

- (xiii) The successful tenderer shall facilitate and arrange for necessary logistics for inspection/supervision as deemed necessary at the manufacturing facility for the representatives of the Commissioner of Excise, Government of Tripura. The entire cost shall be borne by the company.
- (xiv) The successful tenderer should provide necessary training to Excise Departmental Officers/Staffs and provide testing equipment/accessories to the Department free of cost.
- (xv) Law Governing the contract:
  - a. The laws of Government of India shall govern this contract.
  - **b.** Irrespective of the place of delivery, the place of performance or place of payment under the contract, the contract shall be deemed to have been made at the place from which the acceptance of tender has been issued.
  - c. In respect of all tender conditions, the decision of the Commissioner of Excise, Government of Tripura shall be final and binding. In event of any dispute arising out of the tender, such dispute would be subject to jurisdictions of the court within the city of Agartala, Tripura.

#### (xvi) Signing of the tender:

- i) Tender is liable to be rejected if complete information is not given therein or if the particulars and date, if any, asked for in the tender are not fully filled in. Specific attention must be paid to delivery dates and also to the terms and conditions of the contract.
- ii) An individual signing the tender or any other documents connected with a contract must specify whether he signs as:
  - **a.** A sole proprietor of the firm or duly constituted attorney of such sole proprietor.
  - **b.** A partner of the firm, if it be a partnership, in which case he must have the authority to refer to a Court of competent jurisdiction any dispute concerning the business of the partnership either by virtue of the agreement or of a power of attorney, or
  - **c.** A constituted attorney of the firm, if it is a company.
  - d. In case of the above, a copy of the partnership agreement or general power of attorney in either case, attested by Notary Public, and should be furnished to the Commissioner of Excise, Government of Tripura or an affidavit on stamp paper of all the partners admitting execution of the partnership agreements or the general power of attorney should be furnished.
  - e. In case of partnership firm, where no authority to refer disputes concerning the business of the partnership has been conferred on any partner, every partner of the firm must sign the tender and all other related documents.
  - f. A person signing the tender form or any other documents forming part of

the contract on behalf of another shall be deemed to be a warranty that he has authority to bind such other persons(s) and if, on enquiry it appears that the person so signing had no authority to do so, the purchaser may, without prejudice to other civil or criminal remedies, cancel the contract and hold the signatory liable for all cost and damages.

## (xvii) Communication of acceptance:

- a. The Award of Contract will be communicated by appropriate mode and as soon as possible the instructions should be acted upon immediately.
- b. The order placed by the Excise Organization shall be treated as complete if the supplies are made within a variation upto +/- 0.1% of the ordered quantity.

#### (xviii) Failure and Termination:

If the tenderer fails to deliver the hologram or any instalment thereof within a period fixed for such delivery in the currency of the tender, the Commissioner of Excise, Government of Tripura may without prejudice to the right of the Purchaser, recover damages for breach of the contract as under:

- a. Purchase or authorise the purchaser of hologram of similar description from elsewhere without notice to the supplier. Such purchase shall be made without cancelling the contract in respect of the instalments not yet due for delivery. Decision of the Commissioner of Excise in this regard shall be final.
  - **b.** Cancel the contract or portion thereof and, if so desired, purchase or authorise the purchase of holograms not so delivered from other firms for procurement of holograms of similar description exactly complying with the particulars as specified and which are readily procurable, at the risk and cost of the tenderer.
- c. Where the action is taken under sub-clause (a) & (b) above, the supplier shall be liable for any loss which the Excise Organization may sustain on that account, provided the purchase or, if there is an agreement to purchase, such agreement is made in case of failure to deliver the holograms within the period fixed for such delivery, within six months from the date of the cancellation of the contract. The supplier shall not be entitled to any gain from such purchase and the manner and method of such purchase shall be at the entire discretion of the authorities of Excise Organization. It shall not be necessary for the Excise Organization to serve any kind of notice of such purchase on the tenderer.
  - **d.** In case the tenderer fails to supply the required goods in the specified period, the Security money will be forfeited.
  - (xix) The successful tenderer shall have to execute an agreement with the Excise Department as may be specified in the Letter of Intent.
  - (xx) The successful tenderer shall make necessary arrangement to ensure continued supply of holograms in future as and when required by the Commissioner of Excise, Government of Tripura as the same rate as finalised in the tender and design approved and finalised by the Department.
  - (xxi) The successful bidder / contractor shall arrange to dispatch the holograms within 1(one) week of receiving such intimation from the Excise Department. The order should be received within 1(one) week after dispatch.
  - (xxii) Tenderer will have to pay by way of liquidating damages, and not as penalty, an amount equivalent to ½ % of the contracted price of the material for any delay as mentioned

above subject to maximum of 10% of such price. For the purpose of calculating liquidating damages, the date shall be 14 (fourteen) days after receiving supply order from the Excise Department. For every week of delay an amount equivalent to ½ % of the contracted price shall be charged.

- (xxiii) Any tenderer having any interest in liquor and alcohol business or having licenses to deal in above related business within the state of Tripura or in any part of territory of India shall not be eligible to participate in this tender. During the tender or later on, if it is found that the tenderer/supplier commit the breach of this condition, the contract shall be cancelled.
- (xxiv) No interest can be claimed in case of delay in making payment beyond the stipulated period of payment.

#### 8. Tenure of tender

The period of contract shall be for period of 5 year i.e. first term of the tender. However, the Commissioner of Excise, Government of Tripura reserves the right to extend the period of contract for another term of 5 years (i.e. second term) of the tenderer after expiry of the first term.

#### 9. Instructions to bidders

- (i) The tenderer should sign each page of the DNIT after being downloaded from the website and upload the signed DNIT with proper seal of the company in "My document" folder as a token of acceptance and commitment for meeting the same. And also agree that they have no right to question the terms and conditions of the tender after submitting the tender documents.
- (ii) Bidder shall take separate printout of the formats of Particulars of tenderer (Annexure-I), Declaration (Annexure-II), and Price Quotation (Annexure-IV). He / She shall fill the necessary information & put signature with stamp/seal, and then scan them into PDF (PDF should be in good resolution). Finally those documents should be uploaded (with digital signing) in Technical folder/Cover and Financial folder/cover. If any of the certificates/documents furnished by the Bidder, found to be false / fabricated / bogus, the bidder will be liable to blacklisted and their EMD will be forfeited.
- (iii) Last date / time for Submission of the Bids: Bids must be submitted within the Bid Submission start and end date and time specified in DNIT. The Commissioner of Excise may extend the dates for issue and receipt of Bids by issuing corrigendum in which case all rights and obligations of the department and the bidders will remain same as previously.
- (iv) , Late Bids The e-Procurement application https://tripuratenders.gov.in will not allow any Bidder to attempt bidding, after the scheduled date and time prescribed in DNIT.
