**REQUEST FOR EXPRESSIONS OF INTEREST (CONSULTANCY SERVICES)**

**Assignment Title: -**

Consultancy Services for Preliminary and Detailed Engineering including preparation of Detailed Project Report for 16 (sixteen) road projects at different locations on the State Road Network for an approximate length of 246.83 km.

The Government of Tripura has decided to procure the intended Consultancy Services for Preliminary and Detailed Engineering including preparation of Detailed Project Report (DPR) for **Construction / improvement / up-gradation / strengthening of roads for better connectivity at different locations on the State Road Network**. The consulting services ("the Services") include:-

(i) The nature of services to be provided by the consultant will be limited to survey and investigations, collection of all relevant data as required in preparing the Detailed Project Report for construction / improvement / up-gradation / strengthening of the existing roads to standard single lane/ intermediate lane / 2-Lane with/ without Paved Shoulder configuration strictly in conformity with latest revision of MoRT&H & IRC guidelines, preparation of detail design and drawings, estimates, bill of quantities etc. along with economic viability analysis, environmental and social assessment, social and environmental action plan as appropriate etc. and also preparation of draft land acquisition proposal, if required.

The list of roads proposed for survey and investigation will be provided by the department to the consultant for preparation of separate DPR for each individual road project.

(ii) These services are expected to be delivered over a period of **9 (Nine) months**.

The indicative Terms of Reference (ToR) subject to modification & finalization before issuing of Request for Proposal (RFP), for the assignment are available at the **e-procurement website <https://tripuratenders.gov.in>**. The Tripura Public Works Department now invites eligible consulting firms ("Consultants"), to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. 
