Limited Tender Enquiry (LTE)

Tripura Rural Livelihood Mission (TRLM) invites application from NGOs registered under Society Registration act-under 1860 for General Awareness of rural youths under Deen Dayal Upadhyaya Grameen Kaushlya Yojana (DDU-GKY), a Central Sponsored Skill and Placement Programme. Applications will be received in the SMMU **upto 3:00 PM on 10/07/2020** in the office of the Chief Executive Officer, TRLM, Bholagiri, Agartala, opposite of EPFO office to be opened on the same day in presence of bidders, if possible. A format is enclosed at annexure-I for submitting quotation by the NGOs.

Terms & condition are given below:

1. An earnest money amounting to **₹5,000** (Rupees five Thousand) only in the form of Deposit at call or Draft drawn in favour of **"TRLMS DDU-GKY"** payable at Agartala from any Nationalized Bank/Tripura Gramin Bank/ Tripura State Co-operative bank shall be submitted along with the sealed quotation. The said earnest money will be converted to security money for successful NGOs who would be offered the work. For others the earnest money would be refunded.
2. LTE should be super-scribed with **"LTE for general awareness on DDU-GKY"**
3. Rate should be inclusive of all Taxes as applicable.
4. Rate should be quoted both in digits and words.
5. Applicable taxes shall be recovered from the bill.
6. NGO should be located in Tripura.
7. NGO should submit the self attested copies of Registration Certificate, PAN card and photocopies of work orders of Govt. Deptt./Organization for advertisement and conducting general awareness works.
8. NGO should have to covered 1(one) SMMU, 8 (eight) DMMU i.e. West Tripura, Sepahijala, Khowai, Gomati, South Tripura, Dhalai, North Tripura, Unakoti alongwith 58(fifty eight) BMMUs for General Awareness of rural youths under DDU-GKY.
9. The rate and work order issued in favour of successful NGO shall remain valid for the FY 2020-21 for similar nature of work as mentioned in the annexure-I, provided that the service during the present work order is found satisfactory.
10. No application would be entertained if not submitted within the stipulated date and time.
11. The undersigned reserves the right to accept or reject any application with quotation including the lowest one without assigning any reason.
12. All disputes lie within the jurisdiction of Agartala only.
