

The Bid Fee should be paid electronically over the Online Payment facility as indicated against each work in accordance to the tender value, is **Non-Refundable** and to be deposited to the Govt. account automatically as revenue. The Bidders' EMD amount shall be refunded to the bidder, after the **"Award of Contract (AoC)"** event is completed in the Tripura e-Procurement Portal, and only on receipt of **"Performance Bank Guarantee"** from the **L1 Bidder** in Physical Form. Lowest Bidder (**L1**) have to deposit **"Performance Bank Guarantee"** within a date and time, as specified by the tender inviting authority through **letter of Intent(LOI)** to the **L1 Bidder** for depositing "Performance Bank Guarantee" in lieu of EMD Refund.
