EoI shall be received till 20/08/2021 up to 3.00P.M in the office of the Chief Executive officer, SMMU, TRLM, Bholagiri, Opposite of EPF office, Agartala. The bids shall be opened on the same day at 4.00 PM, if possible, when the bidders or their authorized representatives may like to remain present. 2(two) formats for submitting details of the firm and quotation are enclosed at Annexure-I & II.

The CA firm shall have at least 5(five) years experience in audit of accounts of Statutory bodies/ PSUs/ Government organization. Preference will be given to the CA firms who have experience in auditing of Livelihood schemes, if there is tie in the quoted rates. Terms & conditions:-

- The work of auditing and 4set for each audit report shall be submitted by the successful bidder firm for the financial year 2020-21, on the basis of the available & relevant records of TRLM.
- 2. Required certificate for non-embezzlement & non-diversion of fund etc. is required to be issued by the C.A. firm, on the basis of the records of the audit work, as applicable.
- 3. Work of auditing of TRLM shall be held at SMMU & other subordinate units including 8 (eight) districts and 58(fifty eight) block (details at Annexure-II).
- 4. The minimum audit fees in compliance of the guidelines of the Institute of Chartered Accountants of India, guideline No-1-CA(7)/03/2016 dated 07/04/2016, for an amount of ₹1,50,000/-(Rupees One lakh fifty thousand) only (including TA/DA and all others expenses excluding GST as per applicable rate) is hereby offered for auditing of annual accounts & records of TRLM for the FY 2020-21 of SMMU, all DMMU & all BMMU's as mentioned at sl no. 3 above.
- 5. Audit fees shall be quoted inclusive of all taxes and shall not be less than that of minimum audit fee mentioned in the EoI. There shall be no increase of rate during contract period. It is mentioned here that, if any bidder quotes rate below the minimum rate mentioned in the EOI, the bidder shall be disqualified for the said EOI.
- 6. The CA Firm must have an Average Annual Turnover of ₹ 15.00 Lakhs and above during last three years (2018-19, 2019-20 & 2020-21). In this regard self attested copies of Balance Sheet shall be attached with the EoI.
- 7. Rate inclusive of all taxes shall be quoted by bidder both in digit & words.
- **8.** The bidder firm is to furnish a self attested copy of the empanelment certificate along with the EoI. If no empanelment certificate is enclosed, the EoI will be rejected.
- 9. The bidder firm is to furnish self attested copies of valid registration no, PAN no & GST Registration certificate.
- 10. Work of auditing is to be completed within 2(two) months on receipt of work order.
- 11. Applicable taxes shall be recovered from the bill.

- 12. The work order shall be issued in favour of successful bidder for auditing of accounts for the FY 2020-21 initially and it may be extended further for a maximum period of 3(three) financial years (on yearly renewal basis) with the consent from both the parties, provided that the service during the period of current work order is satisfactory and subject to empanelment of C&AG.
- **13.** Professional fees should be inclusive of all taxes and TA/DA and other expenses excluding GST as per applicable rate.
- **14.** No quotation shall be entertained if it does not reach this office within the stipulated date and time.
- 15. If it is found that two or more bidders quote the same rate, the selection may be done based on the technical parameter i.e. total no of work done under Statutory body/ PSUs/ Govt. organization by the firm.
