
**ABRIDGED NOTICE INVITING E-TENDER**

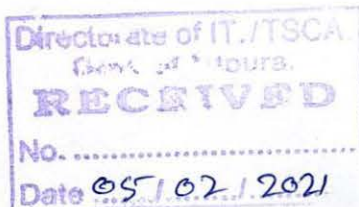


