Terms and condition

- The tenderer shall deposit of Rs.3000 /-(Rupees Three Thousand) as Earnest Money in the shape of D-Call/Demand draft in favour of the Chief Executive Officer, Tripura Livestock Development Agency, Astabal Agartala. The EMD of unsuccessful bidder will be retuned as soon as possible as per Govt.rules.
- 2. Tenderers should have detail postal address along with phone no, Fax no and e-mail address if any In envelop. The interested bidders / tenderers shall submit the bids in two parts, namely "Financial Bid" and "Technical Bid" in sealed envelope separately. The two envelops shall be placed inside a large sealed cover and the same may be submitted. The technical bid shall contain all details viz, name of the items/presentation/company & other technical details. The financial bid shall contain only the rates offered by the bidders. While processing, the technical bid will be opened first and eligible bidders meeting requirements will be short listed. Thereafter, financial bids of only short listed bidders will be opened for consideration and the decision of the technical committee in respect of the quality of the product is final. Bids failing to satisfy the compliance of technical specification will be rejected.
- 3. The rate should be typed and quoted both in figure and words. It should be quoted in Indian currency.
- 4. The rate should be quoted without GST .
- 5. The payment will be made after the satisfactory supply of the items as per the specification detailed in the tender.
- 6. The supply should be made F.O.R destination (Chief Executive Officer, TLDA, Astabal, Agartala)).
- 7. The tender received after the aforesaid date & time shall be rejected. The CEO, TLDA shall not be responsible for any postal delay.
- 8. The following self attested documents with current validity should be submitted along with the tender:
 - i) PAN No.
 - ii) Trade license.
 - iii) GST certificate.
 - iv) Authorization of the manufacturer
 - v) Manufacturer license with ISO certificate (in case of manufacturer)
 - vi) Details regarding similar assignment done in the past/participation in such tender inquiry (if any).

- 9. Authentic documentary proof of exemption from Earnest Money/ITCC/STCC if any should be submitted along with the tender form.

- 11. The item should be supplied with in 15 (fifteen) days from the date of issue of the supply order.
- 12. A penalty @ 1% on the total value of the supply order shall be charged for every week or part of delay beyond the stipulated date of supply. However, relaxation will be entertained only in special circumstances like natural calamity or any other situation beyond human control. In case of failure to supply the ordered items in full within the stipulated period, the earnest money shall be forfeited without further correspondence. The Govt. will not consider any enhancement of rate within the validity period of contract except imposition of any levy or increase in existing levy. Such request will lead to cancellation. All the items will be procured on yearly basis depending on availability of fund.
- 13. The decision of the technical committee of TLDA will be final.
- 14. The legal jurisdiction is restricted to the Tripura High Court , Agartala.
- 15. Conditional tender would be rejected out rightly.

- 16. The successful bidder sought have to deposit 5% of tender value/cost value as security money in the form of D-call /Demand draft drawn infavour of the CEO,TLDA,Astabal,Agartala
- 17. The quality, guarantee period /for the goods should be clearly mentioned.
