- 2) Candidate having Rehabilitation professionals registered with 'Rehabilitation Council of India (RCI)' will be preferred.
- 3) The appointing authority reserves the right to terminate the service of the appointee forthwith or before the expiry of the stipulated period by a short notice without assigning any reason. In that case appointee shall have no right to claim any type of compensations or support from the appointing authority.
- 4) However, undersigned will have right to cancel or alter the order of advertisement and reject any application in any time with out assigning any reason. No TA/DA will be admissible for appearing in the Interview Board.
