But in that case value of document (Form) i.e. Rs.500/- (Rupees five hundred) only will have to be submitted with the Quotation (Bid) in the shape of **Demand Draft/Banker Cheque** with validity not less then 3(three) months from a Nationalized Bank having branch at Agartala drawn in favour of the M.D., THCL, Agartala.
2. The sealed Quotation will be received up to **02.00** P.M. on **06.11.2018** in the office of the undersigned. This may also be sent by **Speed Post/Register Post** which should be reached on or before **02.00** P.M. on **06.11.2018** for acceptance. 6. Rate to be quoted per kg basis including GST both in figures and words.
