**Notice Inviting Quotation**

Sealed quotations are hereby invited from interested suppliers for the work of '**Iron Beds with Sheet and Mosquito Net Holder**' as per the requirement of SMMU, TULM. Quotations will be received in the SMMU, TULM from 18/06/2025 10:00 am to 09/07/2025 03:00pm in the office of the Tripura Urban Livelihoods Mission (TULM), Gurkhabasti, Agartala and to be opened on 09/07/2025 at 04:00 pm in presence of bidders, no further letter or written communication will be done in this regard with bidders.

**Terms & conditions are given below-**

1. An earnest money amounting to ₹10,000/- (Rupees Ten thousand) only in the form of Deposit at call or Demand Draft drawn in favour of "Tripura Urban Livelihoods Mission" payable at Agartala from any Nationalized Bank/Tripura Gramin Bank/ Tripura State Co-operative bank shall be submitted along with the sealed quotation. The Earnest money is refundable, except the said earnest money will be converted to security money for the successful bidder who would be offered the work.
2. The Bed must be a fully good round heavy Iron Pipe structure with 1.5 inch and Sheet (minimum 22 kg) and base of the sheet ( 6 x 4) should be square pipe ( 1.5 x 1.5 inch), Under the 6 X 4 feet Sheet it must be supported with minimum 04 heavy Iron Bars and Mosquito Net Holder ( 8 pcs 12 mm square/round pipe) .
3. The rate quoted by the selected Supplier/bidder for the **Iron Beds with Sheet and Mosquito Net Holder** valid up to 24 months from the date of issue. However, the period of validity of the rate and the work order may be extended further with consent from both parties (TULM & the selected bidder), provided the service during the period of the work order is satisfactory.
4. If the supplying Beds are not found satisfactory, service will be discontinued accordingly.
5. Under the 6 X 4 feet Sheet it must be supported with minimum 04 heavy Iron Bars.
6. In the 4(four) legs of the Bed it should be 4(four) Rubber Guard.
7. The base Height of the Bed should be 2.5 feet. 1(one) side should be height 1 feet and other side height should be 6 inch from the 2.5 feet of the bed and shape of the bed should be in a Square shape with 6(six) Horizontal Bars.
8. The quoted rates are inclusive of fitting, fixing, transportation and other costs. No additional charges will be applicable. Rates should be quoted both in digits and words.
9. Payment will be made on bill submission & satisfactory / work completion certificate from the ULB/ Shelter House. Applicable taxes shall be recovered from the bill.
10. The rate should be included of all taxes.
11. For a successful bidder the beds should be delivered within 30 days after issuing of the award of contract.
12. The contract with the successful bidder for 02 years. Within the Contract Period any kind of damages, broken etc. should be repair (on site) or replaced within the 10 days by the bidder. No costs will be acceptable.
13. The colour of the Beds should be Black or Blue.
14. In case of withdrawal of the service, 1 (one) month prior notice is to be given from either.
15. No quotation will be entertained if it does not reach this office within the stipulated date and time.
16. Any Clarifications of the NIQ related may plz visit SMMU, TULM before the last date of the Tender.

17. All the transportation and installation of equipment at the Shelter House shall be borne by the agency. No extra charges will be allowed.
