**NOTIFICATION**


Considering the protection of students career of the State from the false commitment/ assurance for admission in various professional/ technical courses by the Institutions / Colleges directly or by organizing Edu-Fair and Career Counseling, the Governor of Tripura has been pleased to makes the following Rules regulating the activities of the Organizations /Institutions/ Bodies to organize Educational Fair / Career Counseling for admission of students in the various courses outside the State in the name of “ **THE REGULATION TO ORGANIZE EDUCATIONAL FAIR/ CAREER COUNSELING FOR ADMISSION OF STUDENTS IN VARIOUS COURSES OUTSIDE THE STATE**”

2 This shall come into force with effect from **23-07-2015** (i.e. from the date of Notification) to the State of Tripura.

3 The concerned Organizations/ Institutions/ Establishment shall have to follow the guidelines as framed by the Education (Higher) Department, Government of Tripura as under :-

- (i) The organizer should apply at least 15 days in advance to the Higher Education Department, Government of Tripura being authorized as designated authority for the purpose.
- (ii) List of the participating colleges/institutes alongwith their location and name of the Management/Trusties and the name of the affiliating University/ Board shall have to be furnished before participating in the career counseling/edu- fair through its organizers.
- (iii)The Institute must have the approval of Indian Nursing Council/ Pharmacy Council of India /AICTE/MCI, State Nursing Council and from the concerned University whichever is applicable.
- (iv)The Institute must have its own academic building with the provision of good laboratories, libraries and spacious classrooms & hospital wherever necessary as per norms of respective Councils.
- (v) The Institute must have adequate number of faculties with good teaching background.
- (vi)The College/ Institute should indicate fees structure for each course in each year or the total course fees fixed by the Regulatory Authority of the concerned State Government.
- (vii) The Institute shall disclose in detail the nature of hostel having adequate provisions of running water, safe drinking water, electricity, furniture, food supply (quantity and type), distance from hostel to college on charging extra fees for fooding and lodging from the student at the time of admission.
- (viii) Health care facility shall be made available to the students. The institute shall ensure hospital attachment or proof of tie-up with nearby hospitals in case of treatment to be taken by students fallen serious illness.
- (ix)The College/ Institute shall give full proof or authenticated position of its placement in the preceding year.

4. The organizer should give an undertaking regarding the nature and purpose of fair and that the participating institutes shall not use any unfair means to deceive the students as per the conditionality given above.

5. The organizer shall have to obtain clearances from DM/AMC/Municipality (as the case may be)/ Commissioner of Taxes etc. as relevant and as per the standing instructions on regulations on fairs as fixed by the Higher Education Department.
