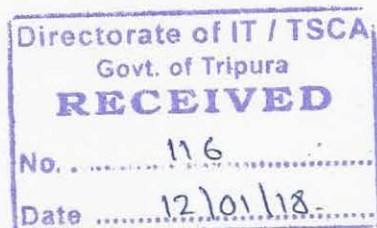

- 5) Quoted rate per unit should be both in word as well as in figure. The rate must be inclusive of all Taxes & Delivery Charge if any.
