**Terms of reference**

1. The Interview Board has to follow the latest guidelines of govt. on recruitment policy circulated vide Memoranda No.23(8)-GA(P&T)/14, dated 11.03.2016 and No. 23(8)-GA(P&T)/14 dated 18.05.2016 for selection of candidates through interview.
2. The date of interview to be fixed and notified by the Department.
3. A panel of selected candidates be prepared in 3(three) times for each category of post. Apart from common to merit list, there shall be ST, SC & UR category merit list to be prepared by the Board on the basis of merit of the candidates.
4. The recommendation of the Board should be submitted to the Government maintaining all formalities with self contained note of the Chairman of the Board.
5. The list of intending candidates (district-wise) have already be prepared and on that basis the interview shall be conducted.
