


Terms & Conditions for supply of Mahindra Bolero Ambulance(Air Conditioned) type B category Road ambulance :-

- 1.** The QUOTATION in sealed covers complete in all respect captioned by QUOTATIONS FOR MAHINDRA BOLERO AMBULANCE must be deposited in the quotation box kept in the chamber of the Sub-Divisional Magistrate,Dharmanagar on or before the time 05:30 p.m of 10/01/2019. The Quotation received after the due date/ time will be rejected.
- 2.** The sealed Quotation will be opened on 11.01.2019 at 12.00 o'clock(noon) in the chamber of the Sub-Divisional Magistrate,Dharmanagar in the presence of the Quotationer /their authorized representatives who wish to be present. If the date is declared to be a holiday, the quotations will opened at the same time on the next working day.
- 3.** The quotation is to be submitted along D-call money as E.M.D of Rs.5000/-(Rupees Five Thousand) only in favor of Sub-Divisional Magistrate,Dharmanagar payable at S.B.I Dharmanagar branch.
