NOTIFICATION

In exercise of the powers conferred by Section 200 of the Motor Vehicles Act, 1988 (Central Act No.59 of 1988) the Governor of Tripura hereby specifies the Assistant Public Prosecutors of all the Courts of Judicial Magistrates of the State to compound the offences mentioned under Sub-section (1) of Section 200 of the Motor Vehicles Act, 1988 for such amount as indicated here in below and only for the cases listed for disposal in the 'Second Maha Lok Adalat' to be held at different Court Complexes of the State on 16.07.2017.

2. The compounding amount for an offence shall not be less than 50% of the minimum fine prescribed in the aforesaid relevant penal section of the Motor Vehicles Act, 1988.
3. This is issued without any prejudice to the general power(s) conferred upon by the State Government to any other authority under Section 200 of the Motor Vehicles Act, 1988.


