The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. **Earnest Money Deposit (EMD) and Bid Fee (Tender fee)** are to be drawn separately on any Nationalized/ scheduled Bank in the shape of **“Deposit at call”/ “Demand Draft”/Fixed Deposit (only for EMD)** in favour of the **Executive Engineer, R.D Teliamura Division payable at Teliamura**. Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid.
